Article 1- Grant of License

The Telecommunications Regulatory Authority (the “Authority”) hereby grants..... (the “Licensee”) this Telecommunications Systems and Telecommunications Services License, under the [updated/new “Act”] (the Act) and the Licensing Regulation, by virtue of which the Licensee is authorized to provide the scope of activities in the licensed area set out herein (the “License”).

Article 2 - Definitions

Any capitalised terms not defined herein shall have the same meaning defined in the Act and Licensing Regulation.

Article 3 - Compliance with the Law

1. The Licensee shall, in addition to complying with the terms of this License, comply with the provisions of the Act, and of any subsidiary legislation made, and other decisions, orders, regulations, guidelines and codes of practice issued by the Authority, under the Act.
2. The Licensee shall designate a senior manager not below the grade of senior managers of the Licensee to liaise with the Authority and follow up the full implementation of the Authority's decisions on all matters related to this License and/or any other decisions. The designee shall be an Omani national except where the licensee provides the Authority with a reasonable justification that this is not possible.

Article 4 - Interpretation

1. In this License, unless the subject matter or context otherwise requires, capitalized words or expressions shall have the meaning assigned to them in the Act, any applicable Regulatory Measures and this License.
2. For the purpose of interpreting the terms of this License the title or headings to any condition shall not be taken into consideration.
3. References to any law, by-law or Regulatory Measures include any modification, re-enactment or legislative provisions substituted for the same.

Article 5 – Scope and authorization

The scope and authorization of the License is as follows:

1. The establishment, maintenance and operation of Telecommunications Systems and Telecommunications Services listed in Annex 1, and/or,
2. The supply of national and/or international services, products or facilities listed in Annex 1, for public or private consumption, that have as a principal feature, the conveyance of signals by a Telecommunications System and Telecommunications Services.

Article 6 - Provisions related to the limited right to apply to use public rights of way and other easements

The Licensee is granted the right as determined by the Authority to apply to use public rights of way from the appropriate authorities in respect of installing the Licensed System

on public rights-of-way, in or on buildings and other property, and in respect of similar works necessary for the provision of the Licensed Services.

Article 7 - No Right to apply for Spectrum Rights

The Licensee is not granted the right to apply for Spectrum Rights.

Article 8 - Co-operation with the Authority

1. The Licensee shall at all times co-operate with the Authority and its authorized representatives in the exercise of the functions assigned to the Authority under the Act and shall make its telecommunications facilities reasonably capable and available for the implementation of judicial, administrative and national security requirements.
2. The Authority shall have access to all premises of the Licensee in accordance with the provisions of the Act.

Article 9 - Licensed area

The Licensed Area shall be the whole of the Sultanate of Oman.

Article 10 – Roll out and coverage obligations

The Licensee shall implement its Public Telecommunications Network and provide its Public Telecommunications Services in accordance with any obligations specified in Annex 2.

Article 11 - Effective date

The Effective Date is...

Article 12 - Duration

This License is granted for a term of ten (10) years from the Effective Date.

Article 13 - Transition

This License replaces any other License granted by Royal Decree, Ministerial decision or Authority decision and shall be the sole License held by the Licensee in respect of scope and authorization under this License.
